Charter of the Children's Fund of the Slovak Republic


"We believe that the world is a better and more beautiful place, because we are also its part."

We focus on searching for what brings people together, and not the things which put them apart. We seek for, define, and approach individuals and groups at risk and people who face exclusion. We support and help individuals and groups in their inclusion, integration and overcoming of barriers. We cooperate with expert public. We inform, engage, and create a space for the people who want to decrease the existence of barriers in our society.

She is a tutor and member of the Virginia Satir Institute in SR. She participates in several projects of the CF SR as the academic supervisor.

Mgr. Denisa Valachovičová has worked in the CF SR since December 2014. She has been the academic supervisor for social projects since December 2018. She studied social work at the Faculty of Education at the Comenius University in Bratislava. She attended the four-year psychotherapeutic training in accordance with the the Model of Satir. She works in the direct work with children, youth, and families in Mixklub project, and besides this direct work she coordinates project Healthy relationships.

Mgr. Mgr. Simona Pretzová has worked in the CF SR since 2013, being an internal employee since April 2017. She is a graduate of curative education and social work at the Faculty of Education at the Comenius University in Bratislava. Besides the administration tasks in the CF SR, she is currently in the direct work with children, youth, and families in Project Mixklub, and she coordinates individual counselling.

Bc. Klaudia Kjurčijská has worked as an internal contact employee in the CF SR since 2017. She graduated from the undergraduate studies of social work at the Comenius University in Bratislava. She is in charge of the administration tasks for the Barrier Account in the CF SR, and she works in the direct work with children youth, and families in project Mixklub.

Mgr. Beáta Piliarová worked as an internal employee in the CF SR from September 2017 to August 2018. She is a graduate of psychology at the Faculty of Arts at the



Comenius University in Bratislava, and she attended the training called "A psychologist in health care". She terminated her activities in the CF SR at the end of summer 2018.

Mgr. Lukáš Štellár has worked in the CF SR since November 2017. He is a graduate of social services and counselling at the Faculty of Social Sciences at the University of Ss. Cyril and Methodius in Trnava. Besides the administration tasks related to the project itself in Mixklub and direct works, he is also involved in prevention coordination, at the same time he works in individual counselling to adults and relatives of the children from the community in Pentagon.

Mgr. Jana Jenesová has worked in the CF SR since September 2018. She studied psychology in Trnava. She works in project Mixklub in the CF SR, where she is in charge of individual tutoring and pre-school preparation for small children. Besides direct work, she also takes care of the administration in the organisation, and since 2016 she has acted as an individual counsellor in the online counselling service – IPčko.sk

Mgr. Diana Tašková has worked in the CF SR in project Mixklub since December 2018. She is a graduate of psychology at the Comenius University in Bratislava. She is involved in direct work with children, youth, and adults. She is in charge of the Preschool and learns a lot.

Mgr. Michal Hacaj worked in the CF SR in project Healthy relationships from 2011 to 2018. He studied psychology at the Comenius University in Bratislava. He was in charge of activities coordination and direct work within the project.

Mgr. Samuel Lamačka has worked in the CF SR since 2005. He graduated from social work at the Comenius University in Bratislava. He worked in project Mixklub for a very long time, where besides coordination and administration tasks he was also involved in direct work and individual counselling. Helping children with disabilities

BARRIER ACCOUNT

"Movement is a natural desire of every one of us"

The Barrier Account (Slovak: *Konto bariéry*) is an extraordinary project of the Children's fund, it has steadily existed for more than 25 years, and it fulfils the needs of families and individuals with disabilities. Thanks to financial help for a compensatory aid from the Barrier Account, young families or young persons can many times make their different task of overcoming different barriers in life as well as in the society easier. In the Barrier Account, we believe that even small acts can change lives for better, and with help of people from outside, donors or sponsoring companies we direct all the financial contributions to those whose need them the most, families themselves, particular children. in the course of its existence, the Barrier Account has helped more than 1,000 applicant by distributing more than \in 700,000 for purchase of different aids, such as electric wheelchairs, accessories to facilitate the life of people with sensory disabilities, etc.

The criteria for receiving a contribution, as well as the overview of the contributions fro the Barrier Account, are published on <u>www.dfsr.sk</u>.

- The Barrier Account has helped hundreds of families from whole Slovakia during more than 25 years.
- > The **Barrier Account** has so far redistributed more than 700 thousand EUR
- The Barrier Account is a public collection permitted by the Ministry of Interior SR
- > The **Barrier Account** has specific rules for the attribution of the contributions
- The Barrier Account has a Governing Board which organises regular meetings and decides on each request for a contribution for compensatory equipment.

Thanks to the Barrier Account, we helped 40 medically disabled children in 2018. We contributed to different medical compensatory equipment in the amount of 27,306.84 EUR (the contribution list is published on www.dfsr.sk).

PUBLIC FUND-RAISING

CF SR has executed project in the city ghetto, so called Pentagon, focused on prevention and counselling for disadvantaged groups since 1992. Mixklub has been a project of the CF SR since 2004, and since 2008 it has been accredited by the Ministry of Labour, Social Affairs and Family of the Slovak Republic in line with the Act No. 305/2005 Coll. for Execution of Social and Legal Children Protection Measures and Social Guardianship.

MIXKLUB

Low-threshold centre for children and youth

"With acceptance and support we create a safe space for growth."

Low-threshold means enabling the maximum accessibility of services – without registration and fees. In practice, this means that a child can come directly from the street and spend their free time in the low-threshold centre with their acquaintances or relatives. They can choose from the proposed activities and they can propose activities as well. They can also ask for an advice and help with solving their problems.

One of the three main projects of the Children's Fund of the Slovak Republic is project Mixklub. Within this project, we organise low-threshold services since 2012 in its own premises directly in so called "Pentagon", at Stavbárska 38, in Vrakuňa (urban part of Bratislava). As the priority, we focus on work with children, youth and adults, which found themselves in this complicated life situation, excluded to the border of the society. This means particularly the financial difficulties, problems in bring up, complicated issue of housing, and overall the environment where people live, which has little stimulus. Direct work is based on three main pillars: prevention, counselling, and assistance.

SERVICES IN MIXKLUB



Open club

Thanks to acceptance and support, we were able to create a safe space for growing up during regular office hours of Mixklub. Within its scope we provided counselling, prevention, discussions and free-time activities focused on sport, creativity and fun. We provided these activities on a regular basis in afternoon hours every Tuesday, Wednesday and Thursday. In 2018 we worked with 239 individuals and 30 individuals in average visited the low-threshold facility during its opening hours.

Tutoring, preparation to school and pre-school

Every child has the right for education, going to school, and the obligation to study. Similarly to other children, the children who come to our facility from little-stimulating environment desire to learn and have many questions. in the course of 2018 we carried out educational activities outside club's regular opening hours. Children would prepare their homework, write projects or improve writing, reading and counting by training their skills. In 2018 we tutored 15 children in total during 36 hours.

Prior to starting at the elementary school, the child goes to a kindergarten. There are children in "Pentagon", who do not have such a possibility, and they spend their free time on the streets when they learn what they are surrounded by. We have had a Pre-school opened for the smallest children since September 2018. It is a creative space for playing an learning. Children train the basis skills needed to start at school, because this is the first education establishment, which they get to experience in their live.

Individual counselling

We provided individual counselling to the youth and adult relatives of the children from Mixklub all year long. We also started to work with the people who visited the counselling office on the basis of the recommendation through our cooperation with the Central Office of Labour, Social Affairs and Family. In the course of the year, counselling moved to a specialised counselling room. The most frequent topic, which the clients wanted to resolve, were the issues of housing, financial situation and debt relief using a personal bankruptcy, executions, parenting skills, applications at the court regarding care for minor children, search for job and part-time jobs. But topics as domestic violence and placement of children into institutional care also appeared. Besides counselling services we accompanied our clients in different institutions. In the course of the year, we cooperated with the Central Office of Labour, Social Affairs and Family, legal office of CU's law faculty students, but also with a private law firm providing *pro bono* services. In the course of the year we carried out 222 counselling sessions with 138 clients.

Prevention in Mixklub

Prevention days took month every day, and during these days children and young people carried out different prevention activities in stations, which had been specifically created for the selected prevention topic. On the basis of our client's needs, we selected the following prevention topics in 2018: online safety, sexuality, hazard games, love, nature, bullying and violence, sports and free time, body care, cigarettes and smoking. 16 children in average attended prevention days,

The news in prevention in 2018 were the **prevention groups**, which were designated for clients from 11 to 18 years of age. In these groups, young people together with their employees carried out activities and discussed partnerships, relationships, friendship, school attendance part time jobs, and other topics, which they brought to the meetings. We performed 13 prevention groups in 2018.



ACTIVITIES WITHIN THE COMMUNITY

Children's Day

Every year we organise Mixák Children's Day in the premises of Mixklub and the adjacent park at Stavbárska 38. In 2018, together with volunteers and children, we again prepared individual stations where children tested their skills related to sports, games, and creativity. While playing and having fun, children and young people earned Mixklubák currency, which they were able to use to buy sports equipment, cosmetics, refreshments, etc. The cherry on the top of this wonderful day was the amazing cake, which we received from a cooperating hotel. Children and their families, employees, volunteers, as well as the people from the surrounding sat behind the table as one big family and enjoyed the cake and the ambience.

St. Nicolas in Mixklub

The littlest children got the chance to meet St. Nicolas. Children enjoyed their individual moments with him, when they could confess to him what they wished for, and pride themselves of what they accomplished in the previous year. At the end, he gave them a small price and a piece of candy.

Christmas Party

With the arrival of holiday season we organised a party where we all met under the Christmas tree. Together we gave out presents, enjoyed refreshments and enjoyed the pre-Christmas time.

At the end of the party, there was a raffle. The main prizes included a bike, skateboard, and board games.

ACTIVITIES OUTSIDE THE COMMUNITY

Mixák daily camp

On the second week of July 2018 we got to experiences adventures together with children in different places outside their natural habitat. We had a barbecue on the Partizánska lúka meadow, we cooled down at a swimming pool during hot summer days, we discovered natural phenomena in a museum, and we saw rescued animals in the Malkia park. The last, and at the same time the most wanted trip took place in Waterpark Senec.

Every year during our daily camps we travel by train, tram or other forms of transport. These are all experiences when children get to know many new people and by overcoming their fear, they start to believe in themselves and they realise how many things they can accomplish.

Creative activities in Lab.cafe

In the course of the year, children joined us to visit the workshop in Lab.cafe. Here they practised their creativity and skills during preparation of t-shirts and key chains. They also learned and tried out that they could make for example a wallet even from an ordinary milk box.

Weekend cabin

In November the children and us spent a beautiful weekend in the area of Pezinská baba. The topic of the cabin trip was "Heroes in us". This topic also inspired the



activities, which we did there. We prepared a barbecue, overcame ourselves during a hike in cold weather, joined together when searching the treasure, which was ingredients for pizza. In the evening we organised and danced at a disco. We are convinced that each of us found a hero in themselves.

We come together and grow further

With this project we followed up the successful project "We come together and we grow" The aim was to connect and get to know again two communities of children and youth, that seem to be different at the first sight. Young people attending low-threshold centre Kaspian in Petržalka joined Club CPPPaP from Ružinov. As of autumn, children started to get to know and meet each other, while they were playing various games and enjoying refreshment. Kaspian, our friendly low-threshold centre from Petržalka organised an amicable foosball tournament in December. During these activities we taught children to respect and get to know each other and observe fair-play. We were able to organise these activities thanks to the support of Nadácia pre deti Slovenska (Slovak children foundation) from the public fund-raising called Hodina deťom (Hour for children)

Statistics of educational situations, prevention, and counselling at Mixklub during regular opening hours

Educational situations – resolving conflict situations between children, between children and employees, educational situations related to the environment, such as cleaning after oneself, destroying the property and material of the centre as well as the surroundings.

Assistance with education in families

HEALTHY RELATIONSHIPS



"Family is a crucial source of support for a child, and this is where positive and effective changes can take place."

Healthy family relationships is a project which provides support to parents and their children with ADHD, who found themselves in emotional crisis and sough for help in bringing up their children. In this project we provide families with comprehensive counselling services. We always perceive the family as a unit, and we regard the problems of a child as a expression of the "functioning" of the whole family. The family with an ADHD and behavioural disorder child usually lives in a huge stress, therefore, it needs support for all the members, however, in particular for the parents. We try to engage the widest circle of the family into our activities, and provide the individual members with general support which will make them stronger. We help them to seek own resources and ways in order to cope with difficult situations. We focus on the growth of self-esteem and self-confidence, support for the change in order to reasonably handle difficult situations, development of social and parenting abilities, understanding the child's needs, support of its healthy mental development, and training on mutual communication.

We work individually or in groups, we focus on the encouragement of relationship and communication in family by means of experiential activities. We assist to schools in integration of diverse children in classes. We also organise weekend stays and experiential workshops for expert and general public. Our activities help to contribute to the improvement of relationships in families.

Our goal set in 2018 was to increase the intensity and quality of provided services. We carried our several important changes in order to meet this goal. For example, we changes the original name of the project "Family with a hyperactive child – Centre for families in crisis" to its current name **HEALTHY RELATIONSHIPS**.

In 2018 we made several changes within the project, and as of September 2018 we expended the project, in which we provide counselling and assistance activities to families on a daily basis. The work team underwent some changes as well, and we prepared it for gradual expansion of project services.

We rented out new premises from the local municipality authority Nové Mesto at Hálkova ulica 11 in Bratislava, which we reconstructed at our own cost, and prepared for the specific needs of the work with families with a child with behaviour disorders.

Activities provided:

Individual counselling for parents was dedicated particularly to educational issues and searching for possibilities to create a positive ambience in the family, which would support the mental development of a child. As for the individual counselling, we also focused on the better understanding of child's needs, and parent's own needs.

Individual working with children focused on the encouragement of their selfconfidence, going through difficult situations in a safe environment. The individual work with children was performed adequately with regard to the age of children (games, art techniques, discussions, etc.). Individual work was employed mainly in case of acute problems of a child, and it led to the stabilisation thereof.

Parents and children groups



Since January 2018 we have carried out two open groups, which were dedicated to the topics of education, training of special parenting skills, parents' personal growth, mutual support and exchange of experiences. The support of children's groups aimed to develop social skills, ability to concentrate on an activity, and to build children's self-esteem. As for the joint activities for parents and children, they participated in the programme which focused on living together and supporting the healthy relationship between the parent and the child.

The **cooperation with schools** focused on supporting expert and pedagogical employees. Since October 2018 we have worked at the elementary school, which had requested from us to support the pupils' integration in a specific class. Several children with behavioural disorders belonged to this class. During our classes, pupils were learning about and adopting new healthier means of stress management, they were making friendly connections and improving their communication. We provided counselling to the teachers in order to obtain new skills when working with a mixed class of children, and this by means of shadowing directly during their lessons as well as by means of individual consultations.

In our direct work with the client we make teams consisting of male and female specialists. We lead our clients to mutual support and respect on the basis of male and female role models.

Supervision and education

Supervision meetings

"Supervision forms an integral part of direct work with the clients of the CF SR".

In order to develop working skills and self-development, we carried out 12 meetings by a group form of supervision, and 10 meetings by means of an individual form. In 2018 we worked mostly on the following topics: work with client's boundaries, how to work with an aggressive client, team work, reasonable conflicts resolving, we were looking for new solutions to develop the abilities to work in a more systematic way towards the working team as well as towards the client.

The CF SR team participated in **254 hours** of supervision in 2018.

Education within the team

This year we also shared our experience with the future experts working in assisting jobs. We are aware of our responsibility towards students, and thus we regularly welcome them in our "backstage". We enabled several students from the Comenius University in Bratislava to connect theory with practice. This was by the practice provided, as well as support in research parts of diploma theses, term theses, or trips to see our activities. We shared out experience from working with children and youth with the colleagues from low-threshold centre Fortunáčik and with our neighbours from Civil Association Odyseus. Thanks to the previous cooperation with the luventa – Slovak Youth Institute, the employees of the CF SR were able to continue in the training related to the topic of the Radicalization of the youth in 2018



as well. We took park in an intensive one-week education course in a closed group of experts from different countries of the world, and we discussed, exchanged experience from direct work, and sought for new vision how to move forward. 2018 was also the year when we visited a company partner for the first time. We told them about our attitude to children and the youth. We know that these kinds of approach are universal, and we can use them e.g. at work meetings.

In 2018 we provided the employees of the Children's Fund o the Slovak Republic with several opportunities for education and development, and thank to them they were able to perfection their skills.

Education for work with youth radicalisation

We gained new perspective to the democracy and radicalisation at the education training called "Youth work against violent radicalisation /The role of democratic competences". Two employees attended the training in Oslo (Norway), where they learned more about human rights in relation to the client, and in the society itself.

Conference of Czech association street work

This was an international expert conference focused on terrain and low-threshold work, where we discovered new inspirations for the development of terrain service, and engaging children and youth in more active spending of their free time on the street.

PDCS – Crisis intervention – working with stress an trauma

We focused the work with stress and trauma on our work team. We used all this time to improve relationships between ourselves to be able to come together on the basis of what we have in common, and to grow based on how different we are.

Bruises on the soul

The main topic of this education was children's abuse. We learned to be more sensitive to this topic, as well as the skills as how to talk to the child victim.

PDCS – How to write to be read

Creative education of how to make writing interesting and how to communicate with public we believe that this immediately reflected on our Facebook account.

STUDENTS TRAINEESHIPS

CF SR's participation in projects

Thanks to support from institutions, companies, and various authorities, we were able to carry out helpful activities in our projects in 2018. We also managed to make improvements in our premises and offer interesting activities to our clients and much more. Below you can find a brief overview of financial aid and its use for the past year.




